On February 6, 2014 Milwaukee County Board of Supervisors approved an ordinance that means pay raises for approximately 8000 workers by requiring entities contracting with the Milwaukee County to pay their em-

ployees a minimum wage of \$11.33 per hour. This wage would bring the workers affected to 100 percent of poverty level for the area.

This "Living Wage Ordinance" is the product of the work of a coalition of over 40 labor, community and faith based groups including IAMAW District 10. Stating early last spring coalition partners knocked on doors, made phone calls and otherwise reached out to eventually garner the support of 12 Milwaukee County Supervisors. This level of support was necessary to override the promised attempt to veto the ordinance by Milwaukee County Executive Chris Abele.

In a statement issued after the vote the lead organization in the drive Jobs Now stated: "This victory represents the truly amazing things that can happen when grassroots and workplace organizing efforts come to fruition".

Detractors of the ordinance have claimed the cost of the ordinance will create a burden on taxpayers. However, County Supervisor David Bowen, who championed the bill counters that "allowing workers to make poverty wages with government funds is not only wrong, it is a drag on the local economy as those workers are forced to rely on the County's social services to pay their bills. When you provide workers with a living wage, it puts more money in their pockets and lifts the economy", stated Bowen.

In addition, representatives of both Dane County and the City of Madison have stated that similar ordinances that have been in effect in their areas for 15 years have not hindered the economy but have helped those areas to thrive.

The coalition is now focusing their efforts on overriding County Executive Chris Abele's promised veto of the ordinance.

"For Abele to do this (veto) now after seeking labor support in his election is very disappointing. We won't forget it," said one coalition member.

#### **State Attempts to Thwart Effort**

Shortly after passage of the Milwaukee County Living Wage Ordinance State Representative Chris Kapenga from Delafield introduced a State Assembly Bill that would out law the passage of local minimum wage laws in municipalities in Wisconsin when they involve state or federal funds.


While that bill has passed the Assembly Committee it has since been met with mixed reactions from other state legislators.

#### **Should You Wait to Claim Social Security?**

Many people file for Social Security as soon as they stop working and/or become eligible for benefits. Full retirement age is 66 for most baby boomers and 67 for those born in 1960 or later, but Americans can claim early worker benefits starting at age 62.

The monthly benefit increases with claiming age by up to 8% a year, so filing early could cause you to lose out on thousands of dollars in benefits, especially if you enjoy a long life.

Consider this hypothetical example: Paul could receive an annual benefit of about \$15,400 if he files at age 62, \$20,500 if he files at age 66 (full retirement age), or \$27,100 if he waits until age 70. If Paul waits until age 70 to file for Social Security and lives to age 95, he could receive about \$677,000 in cumulative benefits (in today's dollars). This compares with roughly \$500,000 if he files early at age 62.

If you are relatively healthy and have other savings to draw upon in retirement, it may be in your best interests to delay claiming benefits. Married couples may also be able to increase their total benefits by coordinating when and how they file for Social Security.

In general, you should weigh your financial resources, potential taxes, health, life expectancy, and other factors when making this important decision. For more information, visit the Social Security Administration website at www.ssa.gov.



Assembly Bill 611 relates to the provision of compensatory time off in lieu of overtime compensation by non-Union private sector employers. This bill destroys long-fought for overtime protections for workers. Instead of fairly compensating an employee for overtime hours worked by paying the employee time and a half in wages, employers will be allowed to substitute comp time off. The employer will have final say over when a worker can take the comp time. This is a destruction of long-standing wage and hour laws that protect workers from overtime abuses by employers.

Assembly Bill 667, the 7-day work week bill, would remove the 24-hour required rest period in a 7-day work week. This bill is a dangerous attack on worker safety and workplace rights. Human beings are not machines. People need rest for their physical and emotional well-being. Workers have earned the right to time off-the-clock to spend with family, friends and to take part in community activities. Removing the required rest period leads to intimidation in the workplace and to an environment where bosses can pressure workers into working every single day of every single month without needed rest.

Assembly Bill 750 would preempt local living wage ordinances that apply to employees whose work is partially or wholly funded by the State treasury. This bill would weaken efforts by local communities to improve wages for working families. In particular, this bill would have a devastating impact on home care workers. The Assembly Labor Committee voted along party lines to approve AB 750 yesterday, February 13, 2014.

Together, these bills pose a frightening and stark reminder that workers' rights are constantly under attack in Wisconsin by GOP lawmakers who care more about scoring political points with big-business allies and campaign contributors than doing right by working people. Please contact your legislator today and urge them to vote NO on these anti-worker, anti-family bills.

#### February 21, 2014, President Obama Takes the Chained CPI out of his Fiscal 2015 Budget

In a great victory for the Alliance, White House staff has announced that President Obama's Fiscal 2015 budget will not include a switch to the chained CPI formula that would limit cost-of-living increases in Social Security and other programs. Alliance members who had worked diligently for months in the hope that the change would not be implemented - and that earned benefits would not be cut – celebrated the news jubilantly. Especially relieved and excited were the thousands of Alliance members who had joined hands at dozens of "Human Chain" events held nationally last July (http://tinyurl.com/ kocng72).

"We are thrilled with reports that President Obama heard Alliance members from across the country and removed the chained CPI cut to Social Security and other programs from his 2015 budget," said Richard Fiesta, Executive Director of the Alliance.

Mr. Fiesta continued, "Now that the pesky chained CPI is out of the way, we can focus on the real task at hand, articulated well by members of Congress like Senators Tom Harkin (D-IA), Bernie Sanders (I-VT) and Elizabeth Warren (D-MA), as well as Rep. Linda Sanchez (D-CA), which is to expand Social Security so that it fits the retirement security needs of today."

Mr. Fiesta added, "The Alliance for Retired Americans made eliminating the chained CPI our top priority of the past year. We held dozens of 'Human Chain' events with thousands of Alliance members all across the country, and are elated that they paid off." Deficit hawks said Obama's move to shelve chained CPI likely kills any chance of a grand bargain for the rest of his term. In an effort to save \$230 billion over 10 years, the President had proposed adopting a new way of calculating benefit increases that assumes consumers don't always pay higher prices for products but rather substitute with cheaper alternatives. The net result is a lower inflation rate than measured by the conventional consumer price index. Just prior to the President's announcement, 117 Members of the U.S. House, led by Rep. Allyson Schwartz (D-PA), had signed a letter (http://tinyurl.com/mmhbowc) urging him not to include the chained CPI in his 2015 budget, and 16 Senators had signed a letter, spearheaded by Sen. Sanders, urging him not to cut Social Security, Medicare, or Medicaid (http:// tinyurl.com/l4xjdlu)


