# **Triangle Fire of 1911**

Two years after the Triangle Fire, New York implemented safety measures but it took **148 burnt young** girls and women to give up their lives for a better

workplace. (53 jumped to their death, 19 jumped down the elevator shaft, 22 died on the fire escape stairs as it pulled away from the building, 54 burnt to death on the 8th floor worksite)



In 1991 the Hamlet chicken processing plant fire in Hamlet, North Carolina, at the Imperial Foods pro-

cessing plant, resulting from a failure in a hydraulic line. 25 workers were killed and 55 injured in the fire, trapped behind locked fire doors.

In 2012 at the Tazreen Fashions factory in Bangladesh 112 workers died in a fire because some managers ordered the employees to ignore a fire alarm and continue to work. Smoke and fire spread throughout the building, many workers were trapped, unable to descend the smoke-filled staircases, and they were blocked from escape by iron grilles on many windows. (then about 6 months later at the same location the building did collapse and 1200 perished)

Whether 1911, 1991, 2012 or anytime in between or in the future workers need to realize the employers do not always have their best interest. **Corporations only exist for the simple reason ... to make money.** 

Now back to the one hour movie on the Triangle Fire which was more than the fire in 1911. It started out a bit earlier in 1909 and garment industry in New York City. There were some 500 different manufacturers employing more than 20,000, mostly women and young girls, who immigrated from Europe and become a part of the American dream.

The workers, as now, were considered an asset, an exploitable resource, and the free market took place of any safety standards. These immigrant workers were managed by their immigrant owners who felt entitled to pay their work-

ers what they wanted how they wanted and the owners deserved the wealth created by their workers.

But 1909 was a time of unrest and the workers did want more. There was a strong movement to Unionize the shops, for a shorter workday, for more pay and a safe work environment. As in earlier times the Union Leadership did not support a general strike but one



of the Union Organizers, who had been beaten by the police, stood up at a mass meeting and her presentation carried the vote.

Some 20,000 workers went to work the next day but at one single action they stood up at their machines and walked out the door. A city wide general strike was on. Within short time 70 of the manufacturers gave in and accepted a Union shop. Triangle did not and its owners, Mike Blank and Isaac Harris, formed a manufacturers group. This group had their private guards beat the strikers, had the police arrest the strikers and had the judges fine and imprison the strikers.

There was hope for a while when a wealthy heiress, Ann Morgan (father was JP Morgan) marched with the strikers. She also had other 'wealthy' women form their own committee to give support to the strikers. As the strike wore on Ann Morgan continued to give her support for increasing pay but she came out strongly against the request of having a Union shop. She finally stopped giving support.

By early 1910 most of the workers were back and the employers agreed to a Union shop. The Union shop meant more than just wages but the right to challenge workplace issues and safety. Triangle was one of the employers who did agree to improvements but **would not agree** to a Union shop.

The manufacturing for the Triangle Shirtwaist Factory was located on the eighth (8th) floor and the ninth (9th) floor. The owners were located on the tenth (10th) or top floor. There was one freight elevator and one passenger elevator. Saturday, March 25, 1911 was to be a short 8 hour day but suddenly smoke developed on the 8th floor from a discarded cigarette. The flames spread fast and no-one alerted the 200 workers on the 9th floor.

It should not surprise any worker but Mike Blank and Isaac Harris escaped from the 10th floor by crossing over the roof top to the next building!

As the 9th floor filled with smoke the only fire prevention were six buckles filled water but workers could not find them. The fire department came within 20 minutes but their ladders only got to the 6th floor.

Some of the workers did use the fire escape ladders but the weight was to much and the fire escape ladders pulled away from the buildings and the workers fell to their death.

On the last run of the freight elevator workers jumped down the shaft trying to hold on to the cables falling to their death. Burning bodies fell to the street and it was reported to be 3 and 4 deep. The safety nets held by the firefighters broke from the weight of falling bodies. It was reported the same police who had beaten the strikers in the previous year just wept.

The owners were acquitted of manslaughter because it could not be proven that they knew the doors and windows were locked. As a matter of fact they did collect \$60,000 more insurance money than the cost of their factory. They even went on to develop another factory! (capitalism at its best)

What the Triangle Women of 1911 realized they could not look to the laws or the government and that they had to do it themselves.

#### What is ALEC?

ALEC is not a lobby; it is not a front group. It is much more powerful than that. Through the secretive meetings of the American Legislative Exchange Council, corporate lobbyists and state legislators vote as equals on 'model bills' to change our rights that often benefit the corporations' bottom line at public expense. ALEC is a pay-to-play operation where corporations buy a seat and a vote on 'task forces' to advance their legislative wish lists and can get a tax break for donations, effectively passing these lobbying costs on to taxpayers.

Along with legislators, corporations have membership in ALEC. Corporations sit on ALEC task forces and vote with legislators to approve "model" bills. They have their own corporate governing board which meets jointly with the legislative board. (ALEC says that corporations do not vote on the board.) Corporations fund almost all of ALEC's operations.

Participating legislators, overwhelmingly conservative Republicans, then bring those proposals home and introduce them in statehouses across the land as their own brilliant ideas and important public policy innovations—without disclosing that corporations crafted and voted on the bills.

ALEC boasts that it has over 1,000 of these bills introduced by legislative members every year, with one in every five of them enacted into law. ALEC describes itself as a "unique," "unparalleled" and "unmatched" organization. We agree. It is as if a state legislature had been reconstituted, yet corporations had pushed the people out the door.

# **Recent Changes to Certain Multiemployer Pension Funds**

The Multiemployer Pension Reform Act of 2014 allows certain multiemployer plans to ap-

ply to the Department of the Treasury for a reduction of benefit payments. These Plans must be in "critical and declining" status, which means they are projected to run out of money in less than 20 years. Then, plans must apply to the Department of the Treasury for approval, and notify all Plan Participants and Beneficiaries of the application process. If approved, the reduction of benefits application is brought before the Plan's Participants and Beneficiaries for a vote. If rejected by the Plan's members, the reduction

of benefits may only be overturned if the Plan is considered a "large plan," meaning it will require federal funding assistance valued at more than \$1 billion. Only in these cases can the Department of the Treasury override the vote of the Plan Participants and Beneficiaries. The Act also specifies that no reduction of benefits may occur for Participants aged 80 or older, or for benefits based on disability. Limitations on how to calculate the reduction of benefits are based on Pension Benefit Guaranty Corporation (PBGC) guarantees.





# **President Obama Smacks Down Republican Attack on Union Elections**

A streamlined and simpler election process for workers seeking a union will stand after President Obama vetoed a Republican measure that would have blocked the common sense rule changes.

The National Labor Relations Board's (NLRB) new election rule, due to take effect on April 14, is designed to modernize the union certification process and stop companies from unnecessarily delaying union elections. Anti-union consultants often encourage companies to use litigation to slow down representation elections.

"Workers need a strong voice in the workplace and the economy to protect and grow our nation's middle class," said Obama. "Unions have played a vital role in giving workers that voice, allowing workers to organize together for higher wages, better working conditions, and the benefits and protections that most workers take for granted today. Workers deserve a level playing field that lets them freely choose to make their voices heard, and this requires fair and streamlined procedures for determining whether to have unions as their bargaining representative."

The new rule provides for electronic filing of election petitions; ensures employees, employers and unions receive timely information; cuts down on unnecessary litigation and adopts best practices across all NLRB regions.


"President Obama is right in his commitment to vetoing this harmful legislation, and Congressional Republicans should focus their efforts on lifting workers up instead of shutting them out," said AFL-CIO President Richard Trumka.

# **Seniors Corner**

#### Fiesta: Prescription Drug Costs May Increase Under Trans-Pacific Partnership

Senior lawmakers reached agreement on Thursday on a trade promotion authority bill to negotiate the Trans-Pacific Partnership (TPP). Two Republicans — Senate Finance Committee Chairman Orrin Hatch (R-UT) and House Ways and Means Committee Chairman Paul Ryan (R-WI) — negotiated for months on the "fast track" trade legislation with Sen. Ron Wyden, an Oregon Democrat who has faced intense pressure from labor and progressive groups to walk away from the talks. Under fast-track legislation, the final deal cannot be amended by the Senate and would be subject only to an up or down vote.

Labor and retiree organizations have been lining up to oppose this "fast-track" bill and broader portions of the coming TPP. The deal would place barriers on the government's ability to regulate drug prices and impede access to generic drugs. If passed, this deal could significantly increase the price of many medications for seniors.


In a press statement, Alliance Executive Director Richard Fiesta said, "Retirees are deeply concerned about the TPP and the Trade Promotion Authority (TPA) legislation. Unfortunately, the fast track procedures of TPA would enable changes to prescription drug prices to occur without open and full debate."
