Personally the event was somewhat bitter-sweet for me as I was battling some kind of illness on Friday evening and stayed confined to my

room to try to get some rest. Thursday evening I must say I enjoyed a good game of Texas Holdem with some fellow brothers and ended up in 2nd place overall. Congratulations to the winner. After the game a handful of us went out to socialize and unwind. We all had a nice time getting to know some members from John Deere. We have some really good leaders in our group. I encourage you all to take the time to get to know each other when given the chance.

Thursday September 26 Midwest General Vice President Brother Phil Gruber opened Dinner with a brief update on the need to hold another Election for the Grand Lodge Executive Council (our International Union). Watch for further information on this. The unfortunate thing in all of this is that it is estimated to cost approximately \$1.6 Million Dollars to redo this election and it is a very good bet, that the results will not change one bit. That money could be better spent on more important things.

Machinists Union Non-Partisan Political League Co-Director Rick de la Fuente gave us a brief update on the political side of the Nation. This ended with some spirited questions about what we as machinists are going to do about Congressional Leaders in this state of Wisconsin that appear to be in a more Liberal area and continue to hold office.

The answer was basically this...If we don't like how things are turning out perhaps we need to get off of butts and get involved. It takes a grass roots movement with personal face to face meetings with real people to find out what concerns they may have and how can we help to change things. It also takes plenty of resources, and much like the vote we need to spend money on that I mentioned above, if the candidates aren't strong, and financial resources aren't there then it might end up a complete waste of money that could be better spent elsewhere. So...I just want to report on our leaders in both the Senate and House on issues that are important to RETIREES. My findings can be verified by going to the GOIAM.ORG website. The information is from the Alliance for Retired Americans 112th Congress dated Jan-Dec of 2011.

Senator Herb Kohl a Democrat scored 100% on issues that would help retirees. Lifetime he is 97%. Senator Ron Johnson a Republican scored 0% on the same issues and lifetime he scored 0% as well.

Reviewing your credit reports regularly is a good idea — to keep track of **your credit history, especially if you plan to apply for a home mortgage.** *From Union Plus.org*

What's in your credit report?

Your credit report captures key data about you and your finances:

Personal information

- Addresses where you've lived
- Employment history
- Phone number(s)
- Variations of your name, if any

Potentially negative items

- Public records like bankruptcy, liens and court judgments
- Credit accounts with defaults and late payments that stay on your credit report an

average of seven years

Accounts in good standing

• All current revolving and installment accounts

Balances and payment histories that may stay on your credit report even after accounts are closed

Requests for your credit report

- Requests for credit that you initiate
- Information about creditors who are monitoring your credit
- Pre-screened offers as allowed by law

It's easy to order your free annual credit report from each of the three main credit bureaus one time per year. Just call 1-877-322 -8228 or go to annualcreditreport.com, the only official site for free credit reports.

How do credit scores work?

The three major credit reporting agencies generally calculate your credit score by evaluating five key criteria:

- Payment history (about 35% of the score)
- Amounts owed (about 30%)
- Length of credit history (about 15%)
- Recently opened credit accounts (about 10%)
- The mix of credit in use, such as credit cards, revolving debt, and mortgages (about 10%)

Typically, the higher the credit score, the less risk a lender takes on. Wonder why this is important? Loan customers with low credit scores may face higher down payment requirements and higher interest rates.

Why do lenders look at credit reports?

Lenders review your credit reports to decide whether or not to lend you money based, in part, on the history they see on your credit report. And they use your credit score to determine how much of a risk you are — typically, a higher credit score indicates less credit risk for the lender. Lenders look at your:

- Payment track record
- Current debts
- Credit history
- New accounts
- Types of credit

What can lower a credit score?

- A history of late payments
- An excessive amount of debt
- Legal judgments, such as a past foreclosure or bankruptcy
- A large number of new credit accounts
- Numerous credit applications

How can I manage my credit?

- Establish your credit history
- Stay current with your bills
- Pay down the amounts you owe
- Keep your balances low on credit cards and other revolving debt
- Don't open new credit accounts you don't need

Keep in mind — negative items in your credit history have less impact as time passes. A missed payment four years ago has a less negative impact on your credit score than a missed payment four months ago.

Our Social Security ...

We just went through 16 days were reactionary put our country's future in jeopardy. They will be back to more of their hateful antics and another will be to attack and diminish our Social Security, *which has not added*

a cent to the national debt.

On our side is **Democrat Representative Linda Sanchez, from California**, who announced the introduction of the Strengthening Social Security Act of 2013, or HR 3118.

The Strengthening Social Security Act of 2013 improves the short-term and long-term health of Social Security in three steps. First, H.R. 3118 would change the benefit calculation formula the Social Security Administration uses, which would increase benefits for all



Social Security beneficiaries by approximately \$70 per month. Second, the Strengthening Social Security Act would change the way the Social Security Administration calculates the Cost of Living Adjustments (COLA), ensuring that benefits better reflect the increasing costs facing seniors today. Third, H.R. 3118 would phase out the current taxable cap of \$113,700 so that all Americans contribute to Social Security taxes fairly.

"Right now, millionaires and billionaires are being given a free pass: an absolute cap on their contributions to Social Security," said Congressman Rush Holt (NJ-12). "No matter how many millions of dollars they earn, they don't contribute even a penny more in taxes. This is wrong. It's time to preserve and expand Social Security by asking the very wealthy to pay the same Social Security tax rate as everyone else." "We applaud Representative Linda Sanchez's bill which enhances benefits and strengthens the long-term solvency of our Social Security system," Eric Kingson, Founding Co-Director of Social Security Works. "Americans are fortunate that Representative Sanchez and the bill's co-sponsors recognize that the nation's retirement income crisis must be addressed by building upon, not cutting, our Social Security, the nation's most reliable retirement vehicle, built by hard work and payroll tax contributions over many generations."

H.R. 3118 is the House companion to S. 567, introduced by Senator Tom Harkin (D-IA) in March, and has been referred to the House Education and the Workforce Committee, as well as the House Committee on Ways and Means, on which Congresswoman Sánchez serves.

The Strengthening Social Security Act has garnered support from Social Security Works, Strengthen Social Security Campaign, AFL-CIO, AFSCME, Campaign for Community Change, Paralyzed Veterans of America, UAW, The ARC, Alliance for Retired Americans, National Education Association, United Steelworkers, and the Senior Citizens League.

Be sure to review your credit reports annually for errors, outdated account information, and even suspicious activity that may suggest identity theft. To correct an error or discuss anything that doesn't look right, contact the credit bureau reporting the item in question:

If you need help improving your score or free assistance with budgeting, you can use Union Plus Credit Counseling and even receive free debt management plans (DMP) if you qualify.

Seniors Corner

Seniors' Issues Front and Center in Government Shutdown, Debt Ceiling Talks

On Wednesday, a letter instigated by **Rep. Reid Ribble (Republican-WI)** was signed by 51 House Republicans, urging Speaker John Boehner (R-OH) to make cuts to Social Security benefits before the debt ceiling is raised and the government is re-opened. To read the letter and see if your U.S Representative was one of those who signed it, go to http://bit.ly/GROQZe The letter recommends:

- raising the retirement age;
- implementing the chained CPI benefit cut to Social Security;
- means testing Social Security benefits for higher income recipients; and
- cutting the FICA withholding rate that funds the Social Security Trust Fund.

"The letter was nothing short of a direct assault on Social Security," said Edward F. Coyle, Executive Director of the Alliance. "This will undoubtedly be a major issue for months to come and into the 2014 elections." A blog post about the letter at The Daily Kos is here:
