# H. R. 3012 Official Name is: Trade Reform, Accountability, Development and Employment Act

Who you vote for is important. Citizens need our elected representatives to work for us and propose laws to benefit us. During the previous eight years there never was a trade bill that Bush did not like and most did not benefit working families. This also goes back to when President Clinton signed the NAFTA agreement.

Now HR3012 is being proposed and already has 137 sponsors in the House of Representatives.

Here is what the **TRADE** Act includes:

**Review:** Requires the Government Accountability Office (GAO) to conduct a comprehensive review of existing major trade pacts by June 10, 2010, including economic outcomes in the U.S. and abroad and various security, human rights, social and environmental indicators.

What Must and Must not be in All Agreements: Sets forth the food and product safety, environmental and labor standards; federalism protection; agriculture rules; national security exceptions; and currency anti-manipulation and trade remedy rules that must be in all American trade pacts. And, because WTO-NAFTA model trade agreements extend far beyond traditional trade matters, this section also lists what cannot be included in future American trade agreements, including service sector privatization and deregulation requirements; bans on Buy American and anti-sweat shop or environmental procurement policies; new rights and privileges for foreign investors to promote offshoring and expose domestic health and environmental laws to attacks in foreign tribunals; and special protections for Big Pharma to limit affordable access of generic medicines.

### **Moving to the Next Level of Recovery**

Now that healthcare is on its way to becoming a reality for Americans, it's time to focus on healing the ravages of the recession. With plenty of people still unemployed, those who have dollars are trying to stretch them further.

Even in tough times, Americans do what we can to help our friends and neighbors. Tough economic times didn't stop people from donating to Haitian relief after the devastating earthquake. People are still filling Hunger Task Force barrels at events where food items are collected. Unemployed businessmen and women are joining mentoring programs, planting community gardens, and stitching up knitted blankets for soldiers in Afghanistan's chilly hill country. And just last week, Dateline NBC focused on a community that came together to donate home renovations for a needy family in Grafton.

The government has some programs in the works. There's still plenty of TARP money earmarked for economic stimulus. Bank of America is back on the rails and plans to repay the bailout funds we loaned them. Communities across the nation are planning to invest in infrastructure, from road and bridge repairs to an ambitious high speed rail system.

But the government can't do it all. The rest of us need to get involved and help things move along.

Here's some things we can all do to get this country working again.



- 1. Contact your congressperson. Lowering costs for small businesses is key to getting businesses to hire again. Programs that offer tax incentives for businesses that hire permanent employees are in the works. The HIRE act passed the Senate, and a similar Local Jobs For America Act is now in the House. Let your reps know that you support this type of legislation.
- 2. Network. Come to Union meetings. Join U-Cubed. Learn what is happening and what initiatives are on the table. If being in a Union has taught us anything, it's that there is strength in numbers. Educating and informing our members and standing together on the issues is necessary for our success.
- 3. Get educated. If your only source of news is Fox News, you're only getting one side of the story. If your only news source is the Huffington Post, you're still only getting one side. Listen to different viewpoints and make up your own mind. Fear has been used to sway public opinion for far too long.
- 4. Buy American. From blue jeans to garden tools, a wide selection of goods are still produced in the United States. Shopping at Wal-mart might save you a few dollars, but the cost of shopping there isjobs lost to China and your hard-earned dollars going overseas. ## **Retirement Planning: Ask the Right Questions.**

How much can you count on Social Security or an employer pension plan for financial support during retirement? The answer lies in your individual circumstances and in your ability to ask the right questions.

#### **Social Security**

To determine the approximate amount you'll receive from Social Security, submit a Request for Earnings and Benefits Estimate Statement (available from your financial professional, or through your local Social Security office). You'll receive a benefit estimate based on your normal retirement age. Keep in mind that while 65 is the typical retirement age for those born before 1959, it may be higher for those born later.

If you're considering early retirement, determine when you can receive Social Security benefits, and how this will affect your future benefits. For instance, partial benefits may be available as early as age 62. However, this may mean a permanent reduction in benefits.

#### **Pension Plans**

Your employer pension plan also affects your retirement picture. Be sure to ask these questions:

- Will benefits be adjusted for inflation?
- If I die, will my spouse receive benefits?
- Are benefits based on years of service or on earnings?
- When are my benefits fully or partially vested?

For help in gathering answers to these questions, ask for a copy of the Summary Plan Description (SPD) to assist you. Many questions need to be asked before you can determine if you're on the way to a successful retirement. Be sure you're asking the right ones.

# **Special Extra Earnings for Military Service**

Since 1957, if you had military service earnings for active duty (including active duty for training), you paid Social Security taxes on those earnings. Since 1988, inactive duty service in the Armed Forces reserves (such as weekend drills) has also been covered by Social Security. (contact Social Security)

Under certain circumstances, special extra earnings for your military service from 1957 through 2001 can be credited to your record for Social Security purposes. These extra earnings credits may help you qualify for Social Security or increase the amount of your Social Security benefit.

Special extra earnings credits are granted for periods of active duty or active duty for training. Special extra earnings credits are **not** granted for inactive duty training.

If your active military service occurred **From 1957 through 1967**, we will add the extra credits to your record when you apply for Social Security benefits.

From 1968 through 2001, you do not need to do anything to receive these extra credits. The credits were automatically added to your record.

After 2001, none.

## Reimbursement of Lost Time for Committee Person

While you will be reimbursed for lost time it may not be as fast as you would like if proper procedure is not followed. Please be aware reimbursement will only be done as stated in the letter from District 10 to Financial Officers dated January 23, 2009.

This must happen or be on file at the Lodge office:

- W4 must be completed by you and on file at the LL66 office. This needs be done only once.
- Properly complete the Lodge 66 Reimbursement Form.
- Lost time must be approved by your business agent at District 10.

Since October 2006 all lost time is paid by ADP payroll. Payroll is done only twice a month. If you miss one payroll date then it will have to wait until the next. Lost time reimbursement forms must be into the LL66 office before the Monday of a payroll date.

# **Applications for new members**

It is the responsibility of each shop chair to make sure new employees fill out the Machinists Union Membership Application. This needs to be done before the Union Security clause date and then: (a) one copy is kept by the new member; (b) one copy goes to your payroll department; (c.) one copy is sent to United Lodge 66.

We do provide all shop chairs with the new member application and self addressed stamped envelopes. Before your worksite runs out of either you need to contact this office and more will be sent.

# **Honorary Withdrawal Card**

#### There is a \$1.00 Fee - It Is Not Free

There has always been a fee for the withdrawal card. All too often a member sends in the application for the card and expects one at no cost.

Withdrawal cards are allowed if:

- Left the trade because of illness
- Obtained employment outside the trade or industry.
- Furthering education.
- Obtained a supervisory position above the rank of working foreman.
- Because of circumstances over which I have no control, am compelled, as a condition of employment, to join another labor organization.

In order to get the withdrawal card a member must obtain such within two months of paying dues.

### **Seniors Corner**

#### House Passes Historic Health Care Bill, Obama Signs It Into Law

Alliance Executive Director Edward Coyle was with the President as he signed the bill into law. "This landmark act will help current and future retirees in several specific ways," said Mr. Coyle. He listed:

- Closing the Medicare "doughnut hole" coverage gap so seniors will no longer have to cut dangerous corners on their medications;
- Eliminating co-pays for preventive screenings to help older Americans more quickly and affordably identify and treat diseases such as cancer and diabetes.
- Reducing costly health problems by assisting pre-Medicare retirees with insurance costs and banning discrimination based on pre-existing conditions.

Many provisions go into effect quickly:

- A \$250 rebate for Medicare beneficiaries who fall into the doughnut hole gap.
- A 50% discount on drugs in 2011 for individuals in the doughnut hole;
- By 2011, free annual check-ups for seniors in Medicare, without having to make a copayment for mammograms, colonoscopies and other preventive screenings;
- A prohibition on insurers from placing lifetime limits on coverage; and
- A prohibition on "rescission" or dropping coverage when individuals become sick.
