Johnson Controls is one of many Milwaukee Manufacturers taking advantage of low wages and exploiting the workers in Mexico as it moved its operations over the border. To my benefit it provided the opportunity to move on and take on new challenges within United Lodge 66. It started as secretary treasurer for this great United Lodge 66, originally called Badger Lodge 66, in 1993 as part time and full time in 1997. We are the best and have been here longer than any Local Lodge in Wisconsin, even our District came after us. We have survived where others failed. As I told the executive board and the members at our November 12 business meeting my best efforts were to make sure *we are solvent*. We have modified our bylaws after seeing the failing of other local lodges.

Our lodge communications changed when I proposed a newsletter and as I recall then President Tom Gadowski stated, "If you start it you better be able to continue." That I have done for the last 14 years. From this simple beginning came our website and youtube site and with it a few awards.

The picture represents my other life at Ojibwa Bow Hunters, in New Berlin. The plaque is about a moment, on April 9, 2004, in the Iraq War and the events involving my son as part of the Wisconsin National Guard, 32nd Military Police and the patrol they were on that night. For those 'patriots' who supported Bush and do not know what took place that night, shame on you!





'Absolute Insanity' to Keep Bush Tax Cuts for Wealthy

Republicans on Capitol Hill want to extend the Bush-era tax cuts for the rich, which are set to expire at the end of the year. President Obama and congressional Democrats want to extend the cuts for middle- and lower-income families, but not for persons making \$250,000 or more.

Scott Walkers Bold New Job Plan

He's not even sworn in yet, but Scott Walker is hitting the ground running to fulfill his campaign promises of job creation in Wisconsin. Walker has promised to create 250,000 new jobs in the state over the next four years.

Walker has also promised to bring the high speed rail project to a screeching halt. The rail program, which would facilitate travel along the Milwaukee-Madison corridor, was to be funded by an \$810 million Federal grant, and would have resulted in nearly 10,000 permanent jobs, to say nothing of construction jobs while the rail line and stations were being built.

Other states, such as New York and Illinois, are vying for the Federal money that Wisconsin is about to turn down.

Spanish train car manufacturer Talgo, which was planning to renovate the old Tower Automotive factory in Milwaukee and open a plant here, is considering locating the proposed factory in Illinois instead, if the rail service is nixed in Wisconsin. Talgo would have created about 125 permanent jobs in their plant.

Money has already been spent by the City of Milwaukee toward the start of this project.

Walker has a history of shortsightedness. In the 2011 Milwaukee County budget, he vetoed a study that would have examined the structure and water quality of South Shore beach. The beach, a jewel of Milwaukee's beautiful shoreline, is often closed in summer due to e. coli, and an Army Corps of Engineers study was proposed to determine how to restructure the shoreline to improve water quality. The study would have been 50% paid for by Army Corps matching funds, would not have put the County over budget, and the resulting improvements would have brought larger revenue to the state in usage fees such as marina fees and fishing licenses, as well as cleaner and safer water for wading and swimming.

Not counting the construction jobs on the rail line and those created by renovating the Tower facility, Walker has already cost the state approximately 10,125 jobs, and he's not even in office yet.

Good start on the 250,000, Scott.

How Long Will It Take to Double My Money?

Before making any investment decision, one of the key elements you face is working out the real rate of return on your investment.

Compound interest is critical to investment growth. Whether your financial portfolio consists solely of a deposit account at your local bank or a series of highly leveraged investments, your rate of return is dramatically improved by the compounding factor.

With simple interest, interest is paid just on the principal. With compound interest, the return that you receive on your initial investment is automatically reinvested. In other words, you receive interest on the interest.

But just how quickly does your money grow? The easiest way to work that out is by using what's known as the "Rule of 72."1 Quite simply, the "Rule of 72" enables you to determine how long it will take for the money you've invested on a compound interest basis to double. You divide 72 by the interest rate to get the answer.

For example, if you invest \$10,000 at 10 percent compound interest, then the "Rule of 72" states that in 7.2 years you will have \$20,000. You divide 72 by 10 percent to get the time it takes for your money to double. The "Rule of 72" is a rule of thumb that gives approximate results. It is most accurate for hypothetical rates between 5 and 20 percent.

While compound interest is a great ally to an investor, inflation is one of the greatest enemies. The "Rule of 72" can also highlight the damage that inflation can do to your money.

Let's say you decide not to invest your \$10,000 but hide it under your mattress instead. Assuming an inflation rate of 4.5 percent, in 16 years your \$10,000 will have lost half of its value.

The real rate of return is the key to how quickly the value of your investment will grow. If you are receiving 10 percent interest on an investment but inflation is running at 4 percent, then your real rate of return is 6 percent. In such a scenario, it will take your money 12 years to double in value.

The "Rule of 72" is a quick and easy way to determine the value of compound interest over time. By taking the real rate of return into consideration (nominal interest less inflation), you can see how soon a particular investment will double the value of your money.

2011 Scholarship Competition

by our International Machinists Union

(online version, click on the above title)

This scholarship competition is open each year to members of the IAM and their children throughout the United States and Canada under procedures and rules of eligibility.

Scholarships make possible the attainment of a Bachelor's degree or a two year vocational/technical certification are determined in competition among eligible applicants that is judged by a special Selection Committee.

Awards to members are \$2,000 per academic year. They are granted for a specific period from one to four years to enable the member to earn a Bachelor's degree or a two year vocational/technical certification.

Awards to Children of Members are: College - \$1000 per academic year. All rewards are renewed each year until a Bachelor's degree is obtained up to a maximum of four years. Vocational/Technical School - \$2000 per year until certification is reached up to a maximum of two years.

An Eligible Applicant Must Be Either:

- An IAM member or;
- The son, daughter, stepchild or legally adopted child of an IAM member.

A Member Applicant:

- Must have two years of continuous good standing membership through the closing of the competition which is February 25, 2011;
- May apply either when entering college or vocational/technical school as a freshman or at a higher level with some college credits already completed;
- May apply as a full time or part time student; and
- If not a winner, may apply again the following year.

Honorary Withdrawal Card

There is a \$1.00 Fee - It Is Not Free

There has always been a fee for the withdrawal card. All too often a member sends in the application for the card and expects one at no cost.

Withdrawal cards are allowed if:

- Left the trade because of illness
- Obtained employment outside the trade or industry.
- Furthering education.
- Obtained a supervisory position above the rank of working foreman.
- Because of circumstances over which I have no control, am compelled, as a condition of employment, to join another labor organization.

In order to get the withdrawal card a member must obtain such within two months of paying dues.



Reimbursement of Lost Time for Committee Person

While you will be reimbursed for lost time it may not be as fast as you would like if proper procedure is not followed. Please be aware reimbursement will only be done as stated in the letter from District 10 to Financial Officers dated January 23, 2009.

This must happen or be on file at the Lodge office:

- W4 must be completed by you and on file at the LL66 office. This needs be done only once.
- Properly complete the Lodge 66 Reimbursement Form.
- Lost time must be approved by your business agent at District 10.

Since October 2006 all lost time is paid by ADP payroll. Payroll is done only twice a month. If you miss one payroll date then it will have to wait until the next. Lost time reimbursement forms must be into the LL66 office before the Monday of a payroll date.
