THERE OUGHT TO BE A LAW

Equal pay has been the law since 1963. But today, nearly 45 years later, women are still paid less than men. In Wisconsin working women are even farther behind. Wisconsin's working women earned 75.8 percent as much per hour as men, while nationwide women earned only 77.6 percent as much per hour as men. I was dumbfounded! In 2007 this nation still hasn't figured it out we still hold tight to our prejudices. I think because I am from an organized workplace I haven't had to deal with this issue I am treated fairly and valued for the work I do. Reading through the resolutions being presented to the delegates I was intrigued by The Fair Pay Restoration Act (also named the Ledbetter act). I went online when I got home and did a little research on Lilly I would like to share her story with membership this should remind us that al-though we are extremely fortunate to have our union the battle is far from over.

Lilly Ledbetter

A lesson in Discrimination

In 1979, Lilly Ledbetter began working at Goodyear Tire and Rubber Company. In March 1998, after years of merit-based pay decisions, Ledbetter inquired into possible pay discrimination by Goodyear. In July 1998, she filed formal charges with the EEOC, and after retiring in November 1998, Ledbetter sued, claiming pay discrimination under Title VII of the Civil Rights Act of 1964 and the Equal Pay Act of 1963.

While the District Court found in favor of Goodyear on the Equal Pay Act claim, the court allowed the Title VII and other claims to proceed to trial. Ledbetter claimed that she had been evaluated unfairly because of her gender and therefore had been paid significantly less than her male colleagues. A jury found in favor of Ledbetter and awarded back pay and damages.

The United States Court of Appeals for the Eleventh Circuit reversed the lower court's decision, stating that Ledbetter could only sue for allegations regarding pay decisions that occurred less than 180 days before her beginning the EEOC process in March 1998, and not those decisions that merely affected pay within the 180-day period. Ledbetter appealed to the Supreme Court. Justice Alito delivered the ruling of the Court, which held that according to Title VII and prior case law the respondent must have acted with discriminatory intent within the 180-day charging period that the Court claimed expired prior to the filing of Ledbetter's EEOC complaint. Furthermore, the Court stated that issuing the checks or denying her a raise in 1998 were not discriminatory by intent. The Supreme Court ignored precedent and the realities of workplace pay discrimination by severely reducing an employee's ability to challenge discriminatory practices.

United Lodge 66 Bylaws 101

(For your benefit and throughout the new year we will have excerpts of your Bylaws as issues arise)

Article VI

Section 1: In order to qualify for nomination as Committeeperson, a member must have been in good standing with this Lodge for one year prior to nomination. The exception being in the case of newly organized shops.

Section 5: Shop Chairperson/s shall preside at all shop meetings unless a meeting Chairperson has been elected. Business Representatives shall not preside over shop meetings; he shall act in an advisory capacity only.

The Ledbetter decision reverses decades of precedent in wage discrimination under Title VII of The Civil Rights Act.

The House of Representatives passed the Ledbetter Fair Pay Act to remedy this ruling on July31st of 2007. The legislation eliminates unreasonable time limits and allows victims of pay discrimination to seek back pay and damages. The Senate companion measure **Fair Pay Restoration Act** (S.1843) is now pending.

Status in the 110th Congress

On June 22, 2007, House Education and Labor Chairman George Miller (D-7th CA) introduced the Lilly Ledbetter Fair Pay Act of 2007 in the House as H.R. 2831. It was considered on the House floor on July 30, and passed the following day by a vote of 225-199.

On July 20, Senate Health, Education, Labor, and Pensions (HELP) Chairman Edward Kennedy (D-MA), along with Republican Senators Olympia Snowe (ME) and Arlen Specter (PA) introduced the Lilly Ledbetter Fair Pay Act in the Senate as the Fair Pay Restoration Act (S. 1843). The bill currently has 25 cosponsors (including Senators Snowe and Specter) and awaits consideration by the Senate HELP Committee.

President Bush has threatened to veto this legislation if it passes. On Friday October12, 2007 CLUW Convention Delegates passed a Resolution in support of The Fair Pay Restoration Act (Ledbetter Fair Pay Act).


