Employee Free Choice Act

In my generation I grew up watching my parents work, save, take family vacations, not worry about healthcare, retire with an adequate pension, and age gracefully. This is not the case these days.

It's all about the numbers.

In the years following WW2, the American workforce was 35% unionized, and made significant gains in wage equity, healthcare, educational credits and other benefits.

But since the 1970s, while employee productivity increased by 48%, wages did not.

With the trend toward de-unionization, spearheaded by big business interests, most recently supported by the Bush administration, less than 7 percent of American workers are represented by unions. As a result, stagnant wages, disappearing pensions, and higher out of pocket healthcare costs has been the burden we've been handed.

The numbers get even uglier.

Under the Bush Administration's tax cuts for the wealthy, the TOP 10 percent took 90% of the Income Gains, and of that the TOP 1 percent took roughly 60% of that, and the TOP 1/10 of a percent took roughly 35% of that, according to FMR. Rep. David Bonior, a member of President- Elects Obama's Economic Transition Team.

Without the opportunity for collective bargaining, employers have less accountability towards the employees that keep their companies running. They can terminate employees without reason, cut benefits, raid pension funds and cut hours and wages. They can ship jobs overseas, or outsource to the lowest bidder, often to people who have no pride in their workmanship nor vested interest in keeping the product American made and held to the highest quality standards.

Part of the problem is that workers voting in support of unionizing have no expectations of privacy; the employer knows how each employee votes on deciding to unionize. While not all employers practice threatening behavior, far too many harass, intimidate and even fire people who support unionizing, with no accountability.

Corporate lobbyists like to paint a picture of greedy unions asking for outrageously high wages, and holding their employers hostage to unreasonable demands.

But what is un-American about wanting a decent wage, reasonable healthcare, and a pension? As American workers, we should not feel guilty for wanting those things.

And the ability to form unions is beneficial to the economy; when workers can bargain for better pay and benefits, their consumer dollar power and financial stability increases, ultimately benefiting the national economy. There's certainly nothing un-American about that, either.

There's been a change in Washington recently. Both President Barack Obama and Vice President Joe Biden support the Employee Free Choice Act. Legislators like Congressman Eric Massa (D - NY) who won his Congressional seat on

Employee CHOICE important legislation when passed in the next session. The changes in Washing common good. That is the

a pro-worker platform, and Sen. Arlen Spector (R - PA), who broke with party affiliation to support this important legislation when the bill was narrowly defeated last June are likely to get this important bill

The changes in Washington reflect a trend toward unity, bipartisanship and working together to achieve common good. That is the very essence of what Unions are all about and why collective bargaining and the Employee Free Choice Act is so important. And that's powerfully Pro American.
