Do You Have Eyes in the Back of Your Head

Milwaukee band Dr. Chow's Love Medicine has a song, "Eyes in the Back of My Head" which seems like the perfect prescription for navigating all the rhetoric and nitpicking surrounding the healthcare debate which has obsessed the media and tied up Congress.

Health insurance company Aetna, worried about meeting projected profit goals, plans to drop over 600,000 clients as well as raise their premiums in order to keep profits firm.

And profits, which pay the \$1.1 million salaries of CEO Ronald Williams and President Mark Bertolini, aren't the only expense Aetna has to meet. Lobbying efforts cost over \$2 million annually. That buys a lot of influence peddling in the halls of government.

The new bill currently in the Senate, which will require all Americans to have health insurance, is not likely to include a public option. It's important to remember that health insurance does not equal health care. Just ask the thousands of Americans who have insurance but cannot afford copays, or whose plans do not cover necessary medications or procedures.

There's a reason that health care stocks closed at record highs on Friday, right after a "compromise" was reached among Senate Democrats that threw out the public option an imposed even tighter restrictions on abortion.

As citizens who will be affected by this legislation, it's important to keep eyes in the back of your head. Get educated and follow the debates. Listen to the experts on both sides of the aisle and let your senator and congressional representatives know where you stand.

Health

A Comparison between the Senate

Who's Covered: About 94% of legal residents under age 65, compared to 83% now. Government subsides to help buy coverage start in 2014. Of the remaining 24 million people under 65 left uninsured, about one-third would be illegal immigrants.

Requirements for individuals: Almost everyone must get coverage through an employer, on their own or through a government plan. Exemptions for economic hardship. Those who are obligated to buy coverage and refuse would pay a fine starting at \$95 in 2014 and rising to \$750.

Requirements for employers: Not required to offer coverage, but companies with more than 50 employees would pay a fee of \$750 per employee if the government ends up subsidizing employees' coverage.

Illegal immigrants: Would be barred from receiving government subsidies or using their own money to buy coverage by private companies in the exchanges.

Care

& House of Representatives Bills

Who's Covered: About 96% of legal residents under age 65. Government subsidies to help buy coverage start in 2013. About one-third of the remaining 18 million people under age 65 left uninsured would be illegal immigrants.

Requirements for individuals: Must have insurance, enforced through a tax penalty of 2.5% of income. People can apply for hardship waivers if coverage is unaffordable.

Requirements for employers: Must provide insurance to employees or pay a penalty of 8% of payroll. Companies with payrolls under \$500,000 annually are exempt and the penalty is phased in for companies with payrolls of \$500,000 to \$750,000. Businesses with 10 or fewer workers get tax credits to help them provide coverage.

Illegal immigrants: Would be barred from receiving government subsidies but permitted to use their own money to buy coverage offered by private companies in the exchange.

The cash prizes will be awarded in May 2010, include: \$500 - First Place; \$300 - Second Place; \$200 - Third Place; and up to five \$100 prizes for Honorable Mention.

Rules: Essays should be approximately 750 words in length. They will be judged on understanding, evidence of original research, writing style and significance. Essays must be typed, double spaced, on white paper. Two copies must be submitted (one may be a photocopy). Please be sure to provide the following information on the cover sheet: your name, address, home telephone, your grade in school, name and address of your school, and if you were encouraged or assisted by a teacher, the teacher's name. Send completed essays to: Prof. Harvey J. Kaye, Center for History and Social Change, University of Wisconsin-Green Bay, Green Bay, WI 54311. Submissions must be postmarked February 15, 2010 or before.

Teachers are urged to assist students in with editorial and research for these essays.

Students may talk to their parents, grandparents, aunts, uncles or other relatives, friends and neighbors about what labor Union membership has meant to them or what struggles they may have faced in their jobs.

Union members are urged to suggest their high school children, grandchildren, nephews or nieces participate and to tell them about what the Unions have meant to them.

The Machinists Union Jobs Now program is a comprehensive strategy to put millions unemployed Americans back to work immediately. Jobs Now calls for a second stimulus package, one focused on investing more in manufacturing and transportation and providing more skills training.

We need to stop pointing fingers but it is time for Congress and the Obama Administration to act.

Two weeks ago the AFLCIO also called on Congress and the Obama Administration to take these five steps for the jobless.

- 1. **Extend the lifeline for jobless workers.** Unless Congress acts now, supplemental unemployment benefits, additional food assistance and expansion of COBRA health care benefits will expire by 12/31/2009. Extending benefits also will boost personal spending and create jobs throughout the economy.
- 2. **Rebuild America's schools, roads and energy systems.** America still has at least \$2.2 trillion in unmet infrastructure needs. We should put people to work to fix our nation's broken down school buildings and invest in transportation, green technology, energy efficiency and more.
- **3.** Increase aid to state and local governments to maintain vital services. State and local governments and school districts have a \$178 billion budget shortfall this year alone, while the recession creates greater need for their services.
- 4. Put people to work doing work that needs to be done. If the private sector can not or will not provide the needed jobs, the government should step up to the plate, putting people who need jobs together with work that needs to be done. These should never be replacements for existing public jobs. They must pay competitive wages and should target distressed communities.
- 5. Put TARP funds to work for Main Street. The bank bailout helped Wall Street not Main Street. We should put some of the billions of dollars in leftover Troubled Asset Relief Program funds to work creating jobs by enabling community banks to lend money to small and medical size businesses.

By law you can get free each year a credit report on you. With this report you will also see who is checking up on you. This is the law.

The best and smartest way is to request one report every four or five months and you will then keep a running report on your credit history and not pay a dime.

Reimbursement of Lost Time for Committee Person

While you will be reimbursed for lost time it may not be as fast as you would like if proper procedure is not followed. Please be aware reimbursement will only be done as stated in the letter from District 10 to Financial Officers dated January 23, 2009.

This must happen or be on file at the Lodge office:

- W4 must be completed by you and on file at the LL66 office. This needs be done only once.
- Properly complete the Lodge 66 Reimbursement Form.
- Lost time must be approved by your business agent at District 10.

Since October 2006 all lost time is paid by ADP payroll. Payroll is done only twice a month. If you miss one payroll date then it will have to wait until the next. Lost time reimbursement forms must be into the LL66 office before the Monday of a payroll date.

Honorary Withdrawal Card

There is a \$1.00 Fee - It Is Not Free

There has always been a fee for the withdrawal card. All too often a member sends in the application for the card and expects one at no cost.

Withdrawal cards are allowed if:

- Left the trade because of illness
- Obtained employment outside the trade or industry.
- Furthering education.
- Obtained a supervisory position above the rank of working foreman.
- Because of circumstances over which I have no control, am compelled, as a condition of employment, to join another labor organization.

In order to get the withdrawal card a member must obtain such within two months of paying dues.

How could the health care reform being debated in Washington, DC affect seniors? There is no final bill but here are a few items in the Senate and House version.

Senate:

- Medicare payroll tax increased to 2.35% on income over \$200,000 a year for individuals, \$250,000 for couples.
- Cuts in Medicare?
- Long-term care: a new voluntary long-term insurance program would provide a basic benefit designed to help seniors to help avoid going into nursing homes.

House:

- To increase prescription drug coverage for seniors under Medicare.
- \$400 billion cuts in Medicare and Medicaid?
- Long-term care: a new voluntary long-term insurance program would provide a basic benefit designed to help seniors to help avoid going into nursing homes.
