Seeking the 8 Hour Day

123rd Commemorative

There's an old saying in Wisconsin – if you don't like the weather, wait five minutes and it'll change. But this May 3rd, whether you are firing up the grill or the snow blower, Union members in Wisconsin and everywhere should take a moment to remember the brave men, women and children who marched on a May morning in 1886, risking – and for seven people, losing – their lives so that the rest of us have worker's rights today.

A general strike had begun that spring over the need for an eight-hour workday. By May 1 most of Milwaukee had shut down, but the North Chicago Rolling Mills, a steel plant in Bay View, was still working. On that May 4, 15,000 people – men, women and children – held a rally at 5th and Mitchell, and then marched toward the Mill. At Bay Street, troops called out by Governor Jeremiah Rusk were given the order to fire on the marchers. Seven people – one, a retired worker, and one a child – lost their lives.

At the intersection of Russell and Superior Streets is a small memorial park. The peaceful green spot overlooks the lakefront near the Coast Guard Station and the new Lake Michigan Ferry.

The workers of 1886 were not successful that day nor for the next few intervening years, but eventually they prevailed. Union or not, the eight hour day is standard, and safe workplace rules, vacation policies and benefits are the norm, not the exception.

There've been a lot of changes to Milwaukee in the intervening years. Milwaukee is a city where people buy Fair Trade coffee at local coffeehouses and Fair Trade goods at stores like Future Green and The Outpost. The eight-hour workday is standard, and people voice their opinions in newspapers, over radio waves and blogs without fear of being shot by the government.

But those that would oppress are still out there. There are sweatshops overseas. Pirates still patrol waters off the coast of Somalia, ready to profit off the labor of others. Anti-Unionists seek to defeat legislation in this country that would give workers the right to Unionize without fear of losing their jobs; they do this with intimidation and misinformation.

This May 3rd we would do well to remember the words of John Cronen, Third Engineer on the Maersk Alabama, the ship that repelled pirates in the Indian Ocean. "We're American seamen. We're Union members. We stuck together and we did our jobs. That's how we did it."

United Lodge 66 Part of Milwaukee History

In 1897 the AFL renewed the drive for a reduction in the workweek and the Machinists Union was called upon to lead. It took until 1900 to reach an agreement called, the Murray Hill Agreement, providing for a nine hour day effective on May 20, 1901.

Corporations went to the nine hour day but cut pay by 10%. **The Machinists Union repudiated this and ordered a nation wide strike on May 20, 1901**. Our minutes reported 'the members of Lodge 66, 300 and 301 all heeded the strike call. All Machinists walked off the job at Filer and Stowell; Kempsmiths; Pawling and Harnischfeger; Browning Pfeiffer and Smith; Milwaukee Harvester; 99% were out at Lutter and Giess; 90% at E. P. Allis and Milwaukee Electric; and 75% at Nordberg Manufacturing and Kearney and Trecker.

This strike only lasted eight weeks while not successful did not end the fight for a reduced work week.

Scholarship Program of United Lodge 66

This program is meant to assist two high school seniors that are children of a United Lodge 66 member. Listed below are the criteria for the Scholarship Selection:

- 1. Two (2) \$500 scholarship annually.
- Only seniors in High School that are children of Machinists Union United Lodge 66 Members and those that are seeking post High School Education are eligible.
- 3. An essay must be written and **must be based on how Unions have been important to your family and community** to be considered for the Scholarship. Information should be gathered from your parents or relatives and the struggles they may have faced in their jobs. The essays must be at least 500 words in length. **Please note, "Essays written from Labor History Books, encyclopedias, etc., will NOT BE ACCEPTED."**
- 4. Essays must be sent to: United Lodge 66, 2611 W. Oklahoma Avenue, Milwaukee, WI 53215. Essays will be given to the Scholarship Committee to review.
- 5. After a review of the competency of each essay, a selection process will follow and the winner will be the essay that best meets the requirements stated above.
- 6. One half of the Scholarship will be paid directly to the school in the first semester (fall 2009) in which the individual is enrolled. The second half will be paid during the second semester (spring 2010) and also sent directly to the school. Selections of essay winners will take place at the September Lodge Meeting. The essays must be in at United Lodge 66 office by July 31, 2009 or postmarked July 31, 2009 Absolute, no entries will be accepted past this date.
- 7. Notification of availability of Scholarship will be published in the Badger *Lodge News*, our Website, and posted in all worksites.

The selection committee will be executive board members. We urge all Union parents in United Lodge 66, with High School Seniors in their family, to encourage their children to enter this contest for consideration of a Scholarship. All entries become the property of United Lodge 66 and winning or any entries will or may be published in the *Badger Lodge News*, our Website.

Once we have received the retiree or exempt card from our International it is sent to the retiree with: (a) current newsletter from the Wisconsin Alliance for Retired Americans; (b) a nine page handout from our Retiree Department on, Medicare Supplemental Insurance, Part D Prescription Plan, Dental, Vision and hearing plan, long term care insurance, and low cost prescription drug program.

Obama Addresses Medicare, Social Security in Economic Speech In a speech at Georgetown University last week, President Obama assessed economic recovery efforts, linking health care costs to broader economic problems and speaking of the need for health care reform to reign in the expenses of Medicare and Medicaid. He also called on Congress to "get serious" and stop postponing difficult decisions in order to accomplish health care reform this year. Laying out his vision for America's economic future, the President restated the role of Social Security as part of a secure retirement, speaking of a need to focus on the program's long term stability after health care is achieved. "The high cost of health care in this county is not just emptying the pockets of retirees," said Edward Coyle, Executive Director of the Alliance. "By eliminating wasteful spending like overpayments to private insurance companies for Medicare Advantage plans, we can take the first step toward getting our economy back on track and having quality, affordable health care for our citizens."
