Wisconsin State Council of Machinists

I would like to take this opportunity to thank the Executive Board along with my Local Lodge brothers and sisters for sending me to the Wisconsin State Council of Machinists fall conference. The conference was held in the city of Rothschild, WI which is near Rib Mountain and Wausau. I need to tell you that if you ever are in the area it is well worth your time to visit Rib Mountain State Park. It is a beautiful area for pictures along with a pretty neat observation tower to climb...

As for the conference it began on Thursday September 24th with check-in followed by a dinner. Our speaker was the Co-Director Legislative & Political Dept. of the IAM (Rick de la Fuente). Rick mentioned that the Koch brothers have put Scott Walker "up for sale". He mentioned that Wisconsin is now the 25th Right to Work (RTW) state. We need to keep the potential of National RTW legislation on the radar. National RTW would suppress all wages in the country. Rick went on to say that the Koch brothers have these RTW states bought and paid for, along with the Supreme Court Justices paid for as well. Rick reported candidly that the Democrats have "no shot at taking back the House". He reminded us that the IAM still does not support "OBAMACARE" because of the (Excise Tax) which is a 40% excise tax on high end plans above \$10,200 for individuals and \$27,500 for family coverage starting in the year 2018. Rick went on to say the Hillary Clinton is against this excise tax.

Rick stated that the IAM has already endorsed Hillary Clinton for Presidency. He said that Bernie Sanders "can't win" because he is against defense spending. Our members hold many jobs tied into "defense spending" areas of which Bernie Sanders doesn't support. Rick reminded us that Hillary Clinton is also an "Honorary Member of the IAM". The IAM is not going to support any Democrats who have supported fast-track for the Trans-Pacific Partnership trade agreement. He also said that Bernie Sanders is also against the (Export-Import Bank). This Bank is a federally backed financial institution which makes and guarantees loans. The EX-IM Bank also "offers insurance to American companies so they can do business overseas." The bank guarantees loans for Companies that create jobs for Machinists Union Members.

Our next speaker was WI State AFL-CIO President (Phil Neuenfeldt). Phil started by mentioning the many contributions Russ Krings has given to the state of Wisconsin. Russ Krings then received a standing ovation from the delegates. For those of you that don't know, Brother Krings has retired from his job as DBR District 10 prior to the writing of this report. This writer would like to say that it has been an honor and a privilege working with Russ and I wish him well as he progresses to the next chapter in his life. His heart has always been for the workers under his care and he will be missed. Mr. Neuenfeldt went on to say that state republicans have done everything they can to come after workers but WE ARE NOT QUITTING! The Wisconsin labor movement is in "transition". We need to do more internal organizing

But, within the next four days the group broke into individual ensembles, worked hard and delivered a concert that featured 19 original songs, garnered high praise from those in attendance and left me feeling tremendously privileged to have been a part of this amazing effort.

Begun in 2012, the first wave of the unioNation band has produced a two disc CD and performed at several union events including the Grand Lodge Convention in Canada.

I am anxiously waiting to hear if we are chosen this time around. I am very glad to have represented our Local in unioNation. I would also like to give a special note of appreciation to W3 Instructor and unioNation Chairperson Henry Bagwell for having the vision and skill to organize this program intended to create a new labor music history.

and member education. Since RTW only a small amount of workers have left the UNION, this is because of the hard work of Stewards and Union Leadership. Our focus is on solidarity round tables, accountability with our elected officials. We need to ensure that local politics/boards are more "labor friendly", and we need to continue to organize both internally and externally. Phil said that "union leaders can't just talk the talk; we have to walk the walk". According to polls 60% of all people support unions. We must educate, motivate, mobilize, and organize...

Friday Sept. 25th began with Grand Lodge Rep. (Marty St. Peters). Marty asked all Veterans to stand and be recognized for their contribution to this great country! He reminded us to let our members know that the IAM has a disaster relief fund available to help members in need of assistance. Guidelines do apply but members need to know the benefit is there. The next Grand Lodge Convention will be held in Chicago. There will be a raffle of (one pound of Gold) coming up to help with the fundraising. Marty said we need change the mindset of non-union employees who think ("I don't get those benefits and neither should you", to that of asking the question ("how can I have the same benefits as you?)

The MNPL has contributed more money to the Midwest Territory than this area has contributed. IAM has recognized the attacks on workers in this area. Before the MNPL contributes and funds to potential candidates a few things need to happen...we need to have a meeting between the local lodge/district and the candidate. We then need to let them know OUR ISSUE and see what the candidate's position is on that issue. We then file a report on that meeting so that we can hold that candidate accountable.

Secretary-Treasurer of WI State AFL-CIO (Stephanie Bloomingdale) was our next speaker. She thanked Russ for his leadership and support and wished him well in retirement. She informed the delegates that John Boehner has decided to resign as "Speaker of the House". She reminded us of the importance that we stick together as Union Brothers and Sisters. She said that "Americans work best when Americans work together!" This is not the philosophy of Scott Walker who chooses to divide and conquer. That is the very opposite of what unions are about.

Attorney Steve Kluender of The Previant Law Firm which sole mission is to represent individuals in labor was our next speaker. He spoke to the delegates about the Worker's Compensation Advisory Council. This council is made of 5 members handpicked by Employers. The council provides a vehicle to provide recommendations to the Workers Compensation Laws. Steve stated that the current council is politicized. He said the management proposals would ensure that management/employers along with insurance companies win and the injured workers would lose. Steve provided us with a copy of these proposals which I will have available at the Local Lodge.

Our very own brother Brian Goode of Union Financial was our next presenter. He has a passion for helping Union members prepare for "retirement readiness". He showed a cute little clip about what it's like to be a financial advisor and the challenges that they face. If you do not currently have a financial planner that you trust I personally would recommend Brian Goode and Union Financial. The service he provides to see where you stand currently on your road to retirement is NO COST TO UNION MEMBERS. Brian will then help you develop a plan/strategy to help you in achieving your goals so that you can retire successfully. I honestly cannot think of a good reason for any member not to take the time to speak with Brian or any member of Union Financial and let them help you.

Assistant Minority Leader, Representative 71st Assembly District (Katrina Shankland) spoke with the delegates about the consequences of RTW. She says our economy is lagging while Minnesota is thriving. We have no funding for our roads, and no funding for our education. No republicans are willing to support her proposal that the state be reimbursed for Gov. Walker's personal travel. She touched on the failings of WEDC and the attack on the open records law.

Wisconsin Senator (Julie Lassa) of District 24 met with us on Saturday. She said that "good news is in short supply in Madison". She says that RTW doesn't work and isn't right for our State. She says that the prevailing wage law is the next target for Republicans. People are slipping from the middle class in Wisconsin faster than any other state. As far as WEDC she said that 6000 fewer jobs were created than last year while they spent \$90 million dollars more. Julie says republicans will continue the war on workers. We must keep fighting! Keep contacting your legislatures! Hold your elected officials accountable and GET OUT AND VOTE!

The following was provided to the delegates and I found it interesting to say the least...

I hate Unions.

Therefore, I hate all the gains Unions have won through the years...decent wages, paid holidays, paid vacations, pensions, sick leave, seniority, overtime pay. I believe my foreman should be allowed to fire me if he wants to give my job to his cousin.

I hereby authorize the company to deduct from my check each week the full amount of any wage increase won by the Union and donate it to the American Red Cross.

IAM Applauds Secretary Clinton's Opposition to the TPP

The Machinists Union welcomed the announcement by former Secretary of State Hillary Clinton that she will oppose the deeply-flawed and secretly-negotiated Trans Pacific Partnership (TPP).

"Secretary Clinton has once again demonstrated her strong support for American workers and businesses by expressing her opposition to the deeply flawed Trans-Pacific Partnership," said IAM International President Tom Buffenbarger. "By any measure, the corporate-driven TPP would expedite the offshoring of American jobs and put continued downward pressure on the wages of struggling working families."

Representing nearly 600,000 active and retired members across North America, the IAM was the first major industrial trade union to endorse Secretary Clinton for President.

"The IAM looks forward to working with Secretary Clinton, and others, who want to craft trade agreements that create jobs, raise wages, protect the environment, and ensure the safety of our food. Global trade agreements can be beneficial, but only if such agreements put the interests of ordinary Americans over those of multinational corporations," said Buffenbarger.

Membership Reminders

As the seasons change it is a good time to update any membership information that may have changed (name, address, phone, email, employment). It is very important to keep your membership information up to date with your Union. The companies as a rule do not forward information to the Union.

There are many times when members need to report membership status. You are responsible to keep the union informed of your status. Some examples are laid off, sick leave, and contact information is always necessary. If you leave your job for some reason, there are withdrawal application forms available, Retirement forms, Transfer forms they need to be requested by you as a member. You can ask your committee people or call the hall (414) 671-3800.

Every new member has to fill out a membership application. They are available from committee persons or at the hall. This also goes for reinstatement forms. If you

get a withdrawal card or lapse you membership you have to fill out the same form when you begin employment with the same company you left or go to another shop represented by the Machinists Union.

The most important thing to remember is *YOU ARE THE UNION*. Your involvement is crucial to have good contracts, representation and benefits. The Machinists Union is a very Democratic Union in all off the Officers and Representatives are elected by the Membership. Do your part and be active for a rewarding membership experience.

To find them online: http:// maps.legis.wisconsin.gov. Once this is up you choose assembly or senate in the upper left corner. Then you type in your address in the search field located in the upper right hand corner.

Or you can call 1-800-362-9472. You will need to give your address; then ask who is your state senator and or assembly person; and ask what district you are in.

Once you get the contact information go ahead and give them your opinion but be polite.

Redistricting or Excessive Right Wing Gerrymandering? Fair Elections Group Takes Question to Court

Gerrymandering is defined as manipulating the boundaries of (an electoral constituency) so as to favor one party or class. The word's origin dates back to 1812, when Massachusetts governor Elbridge Gerry drew up a legislative district map so obviously designed to favor his party that it resembled a salamander.

Why is it that in 2012 Democrats won 53.5% of the vote in Wisconsin yet hold only 39% of the seats in the Wisconsin Assembly? According members of the bipartisan group Fair Elections Project Wisconsin it is the result of a gerrymandered map created by republican leaders. In a lawsuit filed in the US District Court for the Western District of Wisconsin the group claims the map is constructed to so excessively benefit republican candidates that there are close to zero percent chances that Democrats will win a majority under it's ten year life.

Adding to the suspect circumstances surrounding the design of this map is that during its creation Republican legislators were only allowed to view their own district lines. And, in order to do so they had to sign a pledge that they would not divulge information about the map to anyone. According to the lawsuit 17 Republican Senators and 58 Republican Assembly Members signed this document. No Democratic legislators were allowed to view the map until it was formally introduced.

The Ugly Perfect Storm

As fate would have it the election of Scott Walker and his Tea Party cohorts in 2010 coincided with the ten-year U.S. Census. Every census creates the data that enables each state to redraw legislative maps to include updated population information. The Supreme court has ruled that these maps must reflect the concept of "one person one vote", meaning that each person's vote should count as much as every other individual vote. In addition the maps are required to include roughly equal numbers of residents, be relatively compact and not discriminate against particular demographic groups such as ethnic or racial minorities.

Every ten years state legislators are required to re-draw their legislative boundary lines in accordance with the census information and have it signed by the Governor. This has only happened once in Wisconsin in the last 30 years due to the Governor and legislators failing to agree on a fair map. When this happens the courts step in and draw the maps.

It is not unusual for maps re-drawn under administrations with Governors and legislative majorities from either party to result in an efficiency gap that favors their party. However the extent to which the Wisconsin map favors Republicans is excessive. "We are so out of the norm," said Attorney Peter Earl, one of the attorneys involved in the case.

Looking at 786 state legislative maps since 1972 it was determined that only 4% had resulted in an efficiency gap similar to the 12% now found in Wisconsin. "Democracy has been eroded by this excessive partisanship," stated Wisconsin Representative Fred Kessler.

So, once again we see more evidence of Scott Walker and his administration aggressively moving to place Wisconsin in a power lock, shrouded in secrecy, while they busily chop away at worker rights all things controlled by the public.

The one thing people who engage in this type of power mongering count on is that we (the public) are not paying attention. When election time comes they rely on us to concern ourselves with one, often emotionally charged, issue while they walk away with more and more of our hard fought-for rights. This is why it is so important that we bring these issues to light and talk about them. Whether you agree or don't agree is not nearly as important as having the conversation. Remember, solidarity is not built in silence!

THIS, as the Republican legislators announced today that there will be no cost of living increase for Social Security recipients because "the cost of gasoline is on the rise" ??? Conservation and our Natural Resources

As was reported in late September 2015 that a land owner, in Sawyer County, wants permission to permanently position a floating bog near his land on the Chippewa Flowage. The problem started with prevailing winds which has pushed the bog near his land sometimes blocking the lake access. He hired a, brought a tugboat, to the lake to push it back. The only problem is that it floated back.

Now this is not any land owner but Richard E. Uihlein, CEO of the Uline Corporation and who has contributed \$3,000,000 to the political campaigns of Scott Walker.

He wants to permanently move the bog away from his land and anchor it to the lake bottom with 50 pilings but sticking 15 feet above the Chippewa Flowage.

This would all have to be approved by the Department of Natural Resources, over which Walker has the final word.

Editors note: most of us lucky to live on a lake and having those floating bogs just have to live with it and not damage nature!

Changing Civil Servants to Indentured Servants

Wisconsin in 1885 passed the first civil service laws. This was first meant to develop a merit system for Milwaukee's police and fire departments. It went on to forbid bribery and other corrupt practices in state and local government hiring practices.

While Walker took away all collective bargaining rights of public employees with Act 10, at least those most important now he want to decimate the civil service rules.

His proposals, at least what is known, would:

- Drop the exams that job candidates for state government are often required to take in favor of a resume system.
- Define 'just cause' for firing employees so the state can immediately dismiss for showing up to work drunk, being physically violent, engaging in sexual harassment, stealing taxpayer goods or not showing up to work for three days in a year with no notification.
- Shorten the appeals process by more half for employees being disciplined or fired..
- Put in place a single employee discipline system across nearly all state agencies.

This would mean that any elected official could give preference to persons they know even over a more qualified applicant. The days of cronyism would return.

There is also the threat, since Walker has already done it, to check the recall petition and see if you signed it!

Balanced Budget? Not His 71 Day Presidential Run

It seems Walker spent money faster than it came in and he has a \$1 million deficit. The campaign spend \$1.9 million on payroll for 80 staffers with several at a rate of \$200,000 per year.

Walker even put his two sons, Matt and Alex, on payroll and each were paid \$1,540 a month, collecting a combined income of nearly \$10,000 during the campaign.

Wisconsin taxpayers paid \$125,000 for Walker's security yet Walker has not reimbursed Wisconsin \$67,280 back to the state.

Building Own Pathway on State Land

Now the Mrs. Elizabeth Uihlein, as also reported in mid September, wants to by some 1.75 acres of state land on Rest Lake, in Vilas County. Her reason is that she owns a condo complex adjacent to this land and wants free access to the lake.

She could not wait and '*modestly*' cut and removed about 500' of vegetation and brush to complete a footpath through this state property!

Any sale of state land would have to be approved by the Department of Natural Resources, over which Walker has the final word.

Editors note: anyone who spends time outdoors and utilizes public land knows it is illegal not to cut a branch!

Democrats rule out entitlement changes in budget talks

Democrats are drawing an early line in the sand for this fall's budget negotiations, saying they will reject any effort to make changes to entitlement programs as part of the talks, according to a source familiar with the discussions.

The declaration effectively limits the scope of the budget talks to a small-ball deal to fund the government for one year, possibly two. Republican senators said in a series of interviews they're more likely to agree to higher funding levels if they can slow down mandatory spending on Social Security and Medicare.

But congressional Democrats are making clear that there will be no changes to those benefits as part of a deal intended to eliminate the threat of a government shutdown from the presidential primary season, as well as stave off budget cuts from sequestration, which are restricting both military and domestic spending.

Democrats do not believe there is a realistic scenario to find more than about \$80 billion in new spending for the military and domestic programs, potentially restricting budget negotiators to a deal that does not last through the election. That would mean lawmakers would have to strike another spending deal in the fall of 2016.

Congressional Republicans want budget cuts or fee increases to pay for any increases in spending, and wringing billions out of the budget for a spending bill is always a difficult exercise. Republicans said they were still optimistic there might be a broader deal.

The negotiations have been complicated by Boehner's impending resignation as speaker and have now been mostly decoupled from the battle to raise the debt ceiling. The current funding bill runs out on Dec. 11, but the debt ceiling must be lifted by Nov. 3, according to the Treasury Department. That makes it very likely that the spending package and debt limit increase will move independently of each other.

As part of a possible budget deal, Republicans had floated cost-of-living adjustments for Social Security and raising Medicare eligibility, which was first reported by CNN. But Democrats say that's outside the bailiwick of the talks.

"If there's going to be any cuts and savings in Social Security it will be kept in Social Security so that the program will last longer," said Senate Minority Whip Dick Durbin (D-III.). "It isn't as if we are going to transfer money out of Social Security to cover our budget needs."

Congress finally agreed on a permanent change to Medicare payments to doctors in the spring after such an agreement eluded them since the 90s, raising hopes among Republicans that entitlements would again be on the table this fall. And, for the budding budget talks, the problem with avoiding entitlements is it creates much less incentive for fiscal conservatives to go along with a budget deal, Republican senators said.

"We've got to get into mandatory spending, those are the cuts, the savings that stick. And most of us would trade higher discretionary spending to do it," said Sen. Jeff Flake (R-Ariz.).

Instead Democrats are open to revenue raisers like spectrum sales or the grab bag of money in the Senate-passed highway bill. But Republicans said Thursday that they were unlikely to raid the carefully crafted transportation bill to pay for other domestic spending.

SSA Announces 0% COLA in 2016, Triggering Major Cost Increases for Medicare Beneficiaries

Social Security Administration (SSA) officials announced on Thursday that there will be no cost-of-living adjustment (COLA) for Social Security beneficiaries in 2016.

The announcement is particularly troubling because it triggers a premium spike and a major increase in deductibles for Medicare beneficiaries. If Congress does not act soon, the Medicare Part B premium could increase by 52%, to \$159 per month, for 30 percent of people with Medicare. Deductibles could increase to \$223 for every person with Medicare.

"We are extremely disappointed about the Social Security COLA announcement," said Robert Roach, Jr., President of the Alliance. "We will take immediate action to limit the damage by addressing the effect the news will have on Medicare beneficiaries."

The Alliance has already begun taking action to deal with the issue as it relates to Medicare. A petition urging Congress to address the matter has gathered more than 100,000 signatures. Alliance members are also asked to contact their Members of Congress directly and urge them to support the Medicare Premium Fairness Act of 2015 (S. 2148 and H.R. 3696), recently introduced by Sen. Ron Wyden (OR) and Rep. Dina Titus (NV).

Click here to email your members of Congress and tell them to support the Medicare Premium Fairness Act of 2015, which would prevent massive Medicare increases in 2016. This bill will prevent next year's massive spike in out-of-pocket Medicare expenses for seniors and people with disabilities.

Virginia Alliance President Ron Thompson is quoted in a <u>New York Times story</u> about the issue. It's just the third time in 40 years that payments will remain flat, and all three times have come since 2010. The main reason for no increase next year is low gas prices. For more information about how this may affect you, watch this previously recorded <u>online chat</u> that the Alliance, Medicare Rights Center and Social Security Works held on Thursday to address the issue.

Why Should I Care About Helping Others Form a Union?

First look at what a benefit belonging to a Union gives to its Members.

- On average Union members make 30% more than their counterparts doing the same job. This done through the Collective Bargaining Agreements (CBA) that clearly establishes pay rates for jobs.
- A true Grievance Process that addresses workplace issues. Giving true representation through your Union with the Company.
- Elimination of pay inequity. Same pay for the same job for everyone doing the job.
- Benefits Package
- Health Insurance (medical, dental, vision)
- Guaranteed pensions

The list can go on but this should give a general idea of what you gain with a Union. Now look at what a Non-Union Worker has.

- On Average makes 30% less than a union worker.
- No true grievance process.
- Usually the final decision is dictated by upper management as final and binding.
- "At Will" Employee.
- Can be let go at any time. No reason need be given.
- NO Wage Guarantees.
- Wages can be changed and no equal pay for equal job needs to be addressed.
- One person makes \$20/hr. while another person doing the same job \$15/hr.
- No True Benefit package.
- Health Insurance that can be arbitrarily changed by the Company without any discussion or agreement with the employees up to and including total dismissal.
- "Pension". Usually a 401k plan that the Company can match or not and can change the matching amounts up to including no match without discussing with the employees. Usually fees and charges are passed along to the employee.

As you can see the advantages of being in a Union outweigh those of being a non-union worker (At Will employee).

The Machinists Union has always strived to help and improve our member's lives. We have stood up to corporate greed, over reaching rules and regulations and greedy self-serving politicians and groups. We have fought for the unorganized. We have fought for their safety, welfare and fairness in the workplace.

Here are Five Good Reasons why workers need to unite to form a Union:

1 - By Working together, they strengthen their ability to win better wages, affordable health care, retirement package and safe workplaces.

2 - According to the U.S. Department of Labor, Union members are much more likely to have health benefits and pensions.



3 - For minority workers, the Union impact is even greater. Women workers who are Union members earn nearly \$9,000 a year more than their non-union counterparts. For African-American workers, the Union differential is also about \$9,000, and for Latino workers the yearly advantage is more than \$11,000.

4 – Along with helping workers win better wages and benefits, unions help all workers by giving working families a stronger voice in our communities, in the political arena, and in the global economy.
