



I wanted to thank the membership for sending me to Leadership 2 at the William W. Winpisinger Education and Technology Center at Placid Harbor, located in Hollywood, MD. My trip started out with a 13 hour drive, which was a two day drive with little side stops to the Harley stores in each state with my sister. I have never seen such a lush, green county side before and it was amazing, I would encourage anyone to take this trip. The scenery was just amazing, and arriving at the Winpisinger grounds and seeing the staff was just as I remembered. The grounds were perfectly manicured and the staff was very welcoming, kind, and helpful. The classes consisted of Collective Bargaining, Issues and Lobbying, Organizing, Advanced Steward Training and Labor History. The classes are very informative, they run from seven in the morning to seven at night and the staff supplies you with all

the tools needed to share with brothers and sisters back home, which I find is very

helpful.

This year we went to Washington D.C and went lobbying, but there weren't any big groups holding up signs, like I had assumed there were would be. We made appointments with our respective representatives from our states and discussed current issues and concerns we have that effect our family, friends and co-workers. At the time there were so many thoughts running through my head, what am I doing, what did I get myself into and will I be able to talk to the professionals we were going to face before the day was over.

We had a mere two days of classes set up for us as preparation for this event, but nonetheless the teachers did an amazing job in supplying us with the information that they could in the small amount of time given. Offices were set up for practice meetings, where the teachers would take on the role of our representatives and run us through what would exactly happen in the next couple of days.

There were five constituents from Wisconsin who all made appointments with Paul Ryan, Ron Johnson, and Tammy Baldwin. Unfortunately, there was a recess and the representatives were not in the U.S. House of Representatives, but we did seize the opportunity to go speak with their staff. During this time I had spoken to them about the issues the Trans Pacific Partnership (TPP) and The Right to Work and how these problems effects not only us, but our family and economy as well. The staff of the Representatives were very attentive, friendly, and knowledgeable. They took notes on

what was presented before them, thanked us for our time, and apologized for the Representatives not being there. The staff had also encouraged us to find a local office if we get a chance to express any more issues or concerns that we have.

After our meetings, I was able to spare some time to go see a few of the monuments before the bus came. I visited the Washington Monument, the World War II Memorial, the Lincoln Memorial and finally the Vietnam Veterans Memorial. Even if a small amount of time was spent there, I still appreciate being able to get to do that and would love to go back to spend even more time there if possible. The Organizing class I found myself in was very interesting, even if I couldn't see myself doing this at first. However, after the practice runs and classes, I had gained more confidence in myself and was ready for anything else the class had to throw at me. The Advanced Steward training had always been fun to me, but if you were late to the class, a donation to the Guide Dogs of America had to be paid and it would have to be more than you had already originally donated. We focused a lot on the Principles of Grievance Investigation, Grounds for a Grievance and the Grievance Process. "The Fighting Machinists: A Century of Struggle", by Robert G. Rodden in Labor History class was a very good book that held multiple stories and the history of our union in there.

#### Voter ID Law - "Don't be Intimidated"

On September 13th, Wisconsin Citizen Action Organizer Anita Johnson addressed IAM Lodge 66 Membership regarding the

details of the Wisconsin Voter ID Law and other important election technicalities. Ms. Johnson told members that the Voter ID Law will be in effect for the November 8th elections, but she emphasized that voters should not be intimidated. There is assistance available for those who need it, and that getting the correct information to all those who want to vote is extremely important.

Regarding the voter ID law Ms. Johnson stated that voters in Wisconsin must present one (1) form of photo ID at the polls in order to vote.

She went through the various forms of acceptable ID and discussed how Wisconsin residents can obtain a free State ID if needed.

She also stated that the address on your ID does not have to match the address on your voter registration. If your ID is questioned based on this issue you should ask to talk to the Poll Captain to resolve the issue.

#### Tell Congress to Say No to So-Called 'Composite' Pension Plans

from our IAM Action Alerts

The IAM and a coalition of union and retiree groups stand adamantly against legislation introduced in the House of Representatives that would make it even easier for multiemployer pension plans to cut benefits. Retirement security for working Americans should be strengthened, not weakened.

The proposed legislation would allow multiemployer pension plans to transition to so-called "composite" plans, reducing the amount they are required to pay into the plan and weakening the financial base for all plans. Reducing contributions would make them vulnerable to market downturns and inevitably result in deep benefit cuts to retirees.



This is a raw deal for American workers. Tell Congress to reject this pension-killing scheme and protect our retirement security. Republicans from Wisconsin in the House of Representatives support this proposal and are not our friends or friendly to your family. We need a secure retirement income. Write to your representative ... now.

"I strongly urge you to publicly reject recently-released legislation in the House Education and Workforce Committee that would create so-called "composite" multiemployer pension plans.

Defined benefit pension plans are supposed to provide guaranteed lifetime income to retirees. This composite legislation would greatly increase the risk of reduced benefits for millions of hardworking Americans, especially in periods of market volatility.

The legislation would provide inadequate funding for composite plans and weaken the funding base for all plans. This would result in unprecedented cuts to retirees' benefits.

The proposed legislation does not even contain the few procedural protections for composite plans participants offered to traditional and legacy plans by the Multiemployer Pension Reform Act (MPRA). Additionally, composite plans, unlike traditional and legacy plans, are not protected by the Pension Benefit Guarantee Corporation (PBGC).

While I don't oppose the concept of new forms of retirement plans, I do oppose legislation that changes pension funding rules in a way that harms retirement security.

This is a raw deal for American workers, and I urge you and your colleagues to reject this deeply flawed proposal."

## Alliance Launches "Protect Social Security Campaign" Urging Key Elected Officials to Come Clean

Alliance members held press conferences in several states this week to announce a campaign demanding that Senators and Senate candidates pledge to protect Social Security for the retirees who depend on the system for their retirement security.

"We will be working to educate elected officials about the importance of Social Security for retirees," said Robert Roach, Jr., President of the Alliance. "Our members want public commitments to oppose cuts in benefits and privatization for current and future retirees. We will host multiple events and actions to educate and inform our members and the public about officials' records on this most important issue."

Sen. Pat Toomey (PA) claimed in the Philadelphia Inquirer this week that he "didn't remember" his privatization stance on Social Security. The Pennsylvania Alliance responded during a news conference at the state Capitol in Harrisburg noting that Sen. Toomey has advocated for Social Security privatization since at least 2001 and even wrote a book outlining his views. He supported transforming guaranteed benefits into savings accounts modeled off 401(k)s. Sen. Toomey has insisted that these private accounts would not apply to retirees or Americans close to retirement, but it would impact millions of younger workers' benefits.

Events were also held in North Carolina, Wisconsin, Arizona, Florida and Nevada. In Columbus Stanley Gates, a student at Ohio State University, sent a powerful message to Senator Rob Portman (OH) about Social Security and what it means to his family and his future.
