Lodge 66 Members Gain Valuable Information at IAM Midwest Territory Educator & Communicator Training Session by *Pepe*

Did you know that Facebook is the top social media channel around the world, with 1.5 billion active users per month? Or that text messaging is the most immediate and preferred method of communication?

You are probably not surprised by these factoids. But the next question is, are unions effectively using these very viable methods to communicate our message? The answer is yes, (if you read our newsletter you know our Communicator has been trying), and we are making progress, but for it to really be successful we have to get everyone on board.

Social media methods of communication were just a few of the many important issues discussed at the Midwest Territory Educator & Communicator Training Session held at District 10 offices in March.

Starting off the session, Education Representative for the Midwest Territory, Joe Gruber led the room filled with Educators and Communicators from Locals throughout the district in an interactive conversation and informational Power Point on the skills, duties and important role of Educators in our Locals. Brother Gruber stressed that in this day and age of Right to Work and constant attacks on unions, educating our members from the day they enter the shop on the benefits of and the reasons for having a strong union is more vital than ever.

For the afternoon portion of the program, Midwest Territory Communication Representative, Latoya Egwuekwe-Smith, provided a very clear and eye-opening view into the many tools and

children of the working classes of this world through the years, how can one not despair for an individual that is made to live a life of disparity even though they are doing an honest day's labor to the best of their ability.

Another item we looked at was labor and politics. This class opened the eyes of this "for the most part conservative" voter in past elections. The term wedge issue was presented. A wedge issue is a social issue, often of a divisive or controversial nature, which splits apart a population or political group. Wedge issues are used in an attempt to weaken the unity of a population, with the goal of enticing polarized individuals to give support to an opponent or to withdraw their support entirely out of disillusionment. Wedge issues are issues that stop us from giving someone our vote rather than voting for them on an issue that looks at the greater good that can be accomplished by getting them into office. This in itself left me with a desire to expand my horizons and do diligent research of candidates' views on labor laws when using my right to vote. It was also explained that too often wedge issues are used to separate people when we really need to stick together for the good that can be brought about and by the power in numbers that is achieved by solidarity. We were also introduced to the IAM website and app www.goiam.org where much of the work related to researching candidates has been done for us. I would encourage all of us to take a look at this, and seriously consider where you want to place your vote for the continued good that Unions will contribute to our future generations.

I remain very grateful to have had the opportunity to have visited the Winpisinger Education & Technology Center. It has been an awesome experience, and I hope we will be able to send others so that the vast wealth of information from the center can be shared with other brothers and sisters.

I thought I might do a brief report on the "Free college benefit" that the IAMAW is offering our members. The benefit makes it possible for you and your family members to earn an associate degree completely online for free. To find more information about the program please visit https://freecollege.goiam.org

I personally started the registration process in September of 2017 when I first found out about the benefit to Union members. Registration was easy to do. I needed to complete a financial aid form thru the fafsa.gov website. Along with that my high

school transcripts needed to be sent to Eastern Gateway Community College. Once the above was completed I was able to meet over the phone with a counselor and register for my first classes.

My first class was CIS101 (Computer Information Systems) which the counselor said was a requirement. I figured I would take that first and the information acquired would help me as I moved along in pursuit of my degree. This particular class touched on Microsoft Word, Excel, PowerPoint and Access. I am glad that I took it first and have been able to use the information in each class I have taken since then by writing reports in Microsoft Word documents or submitting PowerPoint presentations as required assignments.

I am currently on my 3rd class. I have completed CIS101 and also Bus101. My current class is PSC101 which is an introduction to American Politics. I am pursuing an Associate's degree in Business Management with a focus on Human Resources. The degree requires 60 credit hours and each class is worth 3 credits. I am going to be honest here when I tell you this is extremely difficult for me as I am probably averaging 20+ hours a week with my studies, along with my current employer working us 50 hours or more a week on average. Doing all that and still being a husband to my wife and father to my two children is more difficult than I thought. I have had to step back on many other things I did in order to make this possible. Even attending membership meetings can be difficult because that is one evening less that I don't have available to complete my required assignments for that week. I have stepped down from teaching Hunter Education this spring and decided against serving my shop in any leadership role as Chairperson or Steward. Time is now viewed as a nonrenewable resource in my world and I need to use it wisely.

My reason for this letter is not to discourage anyone to apply to the free college program. I believe it is a great benefit to our members. I just wanted to share my experience with those that might have an interest. It is a true college class and not a joke. The professors communicate with you via email and expect you to get your assignments in on time. Classmates are all adults as well and we are required to view and comment on their work as well. Discussion is strongly encouraged and a significant amount of work in each class so far. If I had the schedule to take more than one class at a time this report would be more encouraging, but only taking one class at time because of "life" this degree could take upwards of 4 years to complete. It is still worth it in my opinion as I will be able to use the knowledge gained no matter where life takes me down the road.

Correction Time: The Market Takes a Hit

After reaching all-time highs on January 26, 2018, the Dow Jones Industrial Average and the S&P 500 went into a two-week slide that saw both stock indexes drop by more than 10%, a decline that is typically considered a market correction. (1)

Analysts have been saying for several years that the long, booming bull market was overvalued and due for a correction, so the drop was not a surprise in the big picture. (2) And even after the 10% plunge, the Dow was up 19% over the previous 12 months, and the S&P 500 was up 12.5%. (3)

It's natural to be concerned about this kind of shift, but more important to maintain perspective and focus on your long-term goals. It may be helpful to consider some of the reasons behind the surge of market volatility.

Too Much of a Good Thing?

The initial trigger for the downturn was a better-than-expected jobs report on February 2 that helped drive the Dow down more than 2.5%, a significant decline considering the unusually low volatility in 2017 and the beginning of 2018. The economy added 200,000 jobs in January, marking the 88th straight month of job creation, the longest such run in U.S. history. Wages rose by 2.9% over the previ-

ous January, the highest year-over-year increase since the end of the recession in June 2009. And the unemployment rate held steady at 4.1% for the fourth straight month, the lowest level in 17 years.4

Although the report was great news for U.S. workers, on Wall Street the rosy jobs picture generated fears of higher inflation that might drive the Federal Reserve to raise interest rates more quickly than anticipated. At its December 2017 meeting, the Federal Open Market Committee signaled its intention to raise the benchmark federal funds rate three times in 2018, bringing it up to a range of 2.0% to 2.25%. Theoretically, these changes have been priced into the market, but the strong jobs report made it more likely that the Fed will follow through on its projection and possibly execute further increases if inflation heats up.5

Stocks, Bonds, and U.S. Debt

Higher interest rates rattle the stock market because investors are more likely to move assets out of risky stocks and into more stable bonds, as fixed-income yields become more attractive. Higher rates not only mean increased yields on new bonds but also on existing bonds, as prices are pushed downward to make yields competitive. In addition, the prospect of inflation tends to push bond prices lower and yields higher, because inflation erodes the purchasing power of fixed-income payments.

One reason for the initial reaction to the January jobs report expanding into a full-blown correction is that bond yields were already rising due to other factors. The yield on the 10-year Treasury note — a bedrock of global financial markets — has been rising since tax legislation was proposed in the fall of 2017, and the yield reached a four-year high of 2.85% on the day the jobs report was released.6–7 Although the Tax Cuts and Jobs Act was generally welcomed on Wall Street, bond traders have been concerned that increased Treasury sales to pay for the \$1.5 trillion tax cuts will erode bond prices. This concern was exacerbated by the bipartisan budget deal that further increased deficit spending.8

The Treasury is working to finance higher debt at the same time the Federal Reserve is unwinding its recession-era bond-buying program. With the Fed reducing its bond portfolio, the Treasury must sell more bonds to the public to cover growing deficits. The Treasury recently announced the first increase in bond sales since 2009.9

The question is who will buy these bonds and what are they willing to pay for them? A weak dollar has made Treasuries less appealing to foreign governments, which hold more than 44% of U.S. government debt. With the Treasury market depending more on U.S. investors, supply may be outpacing demand — illustrated by a tepid Treasury auction on February 7.10 The Long View

Although mounting government debt is a serious concern, the stock and bond markets are both driven in the long term by the economy, and the United States looks to be hitting its stride after a long, slow recovery. The global economy, which has been even slower to recover, is coming back as well.

A correction may be disturbing, but it can strengthen the market in the long term by returning equity values to levels that are more in line with corporate earnings and less dependent on investor exuberance. A corrected market may also be less vulnerable to overreaction. On February 14, the Dow and the S&P 500 closed up more than 1.2%, despite a consumer report that showed higher-than-expected inflation. Even with higher prices in January, core inflation (which excludes food and energy prices) is running at only 1.8%, still below the Fed's 2% target rate.11

Of course, no one can predict the future, and you might see volatility for some time. The wisest course may be to remain patient and avoid making portfolio decisions based on emotion.

The return and principal value of stocks and bonds fluctuate with changes in market conditions. Shares, when sold, and bonds redeemed prior to maturity may be worth more or less than their original cost. Administration Moves to Use the "Age Tax" to Charge Seniors More for Health Care Again, this was reported on March 9, 2018

The White House is seeking a package of conservative policy concessions in return for backing a legislative package stabilizing Obamacare markets. The Trump administration has rolled out a list of policy requests that includes allowing health insurance companies to charge older Americans up to five times as much as younger policy holders.

This policy change would require amending the Affordable Care Act (ACA). "The Affordable Care Act limited how much more seniors can be charged by health insurers due to their age," said Robert Roach, Jr., President of the Alliance. "The administration's actions would undo the progress that we have made since 2010."

The White House is also seeking to allow short-term plans — which offer skimpier benefits with lower premiums — to be renewed. Under a process known as underwriting, shortterm plans, exempt from the ACA, can deny people coverage or charge them more based on a health condition. White House officials recently proposed expanding the maximum length of these plans from three months to one year and allowing people to renew the coverage without going through the underwriting again.

Omnibus Spending Bill Provides Additional \$480 Million for Social Security Administration

The U.S. House passed a massive \$1.3 trillion spending bill on Thursday to fund the federal government through September 30. The Senate followed early Friday, and President Trump signed the measure on Friday afternoon.

The Omnibus provides \$12.8 billion for the Social Security Administration's (SSA) administrative budget - a \$480 million increase over last year. That includes an increase for general operations, as well as designated amounts of \$284 million for Information Technology modernization and \$100 million for reducing the disability hearings backlog.

Despite the Omnibus, House Speaker Paul Ryan doubled down on cutting Medicare, Medicaid and Social Security, on Tuesday, saying Congress will "have to keep at it" on cutting so-called "entitlements."
