Covid 19 Resources

As we continue to wage an ongoing battle against COVID-19, Wisconsinites of all backgrounds and circumstances must continue to practice safe, precautionary steps to ensure we are all safe. Unfortunately, in the last week Wisconsin has seen its highest levels of newly reported cases since May, reaching an average of over 400 new reports per day.

During this difficult time, following the safety guidelines provided to us becomes more important. COVID-19 remains very contagious, so keeping social distancing and wearing masks are absolutely essential to protecting ourselves and others. Please consider some of the Wisconsin Department of Health Services recommendations on how to avoid contracting and spreading the virus, particularly with the upcoming 4th of July holiday and the many beautiful summer days ahead:

- Stay at home as much as possible (avoid gatherings of 10 or more people)
- In public remain 6 feet apart for social distancing
- If possible, wear a face covering or face mask when physical distancing is difficult
- Wash your hands regularly for 20 seconds with soap and water
- Avoid touching face, eyes, and mouth in public

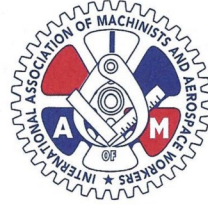
